TRADE MISSION

USCCC will lead several trade missions to China this year. The first one will be leaving for China on April 12 and return to the US on April 23. The purpose of the mission is to assist US companies in gaining a first hand understanding of the opportunities and challenges of the Chinese marketplace, as well as to establish direct contacts with potential trading partners and government officials. The Trade Mission will start in Shanghai, and continue to Ningbo, Guangzhou, Xinhui, Fushan, Zhongshan (we will attend the Zhongshan Xiaolan Light Manufacturing Fair), Dongguan, and Shenzhen for a period of approximately 12 days. The Trade Mission's focus is on plastics, metallurgical, furniture, fixtures, accessories, lighting and consumer electronics. Subject to the interest of the participants, in Ningbo, we will visit several precision casting foundries, textile factories, plastics molders, metal stampers and related industries; in Xinhui, Fushan, Zhongshan, Dongguan, and Dongguan, we will visit furniture, fixtures, lighting, consumer electronics factories, plastics, and other light manufacturing industries. To ensure the success of the Mission, we will limit the number of members to no more than 15 with no more than two representatives from the same company.

RECENT AND UPCOMING U.S. INTERNATIONAL TRADE COMMISSION INVESTIGATIONS HEARINGS

A. <u>Five-year (sunset) review adequacy determination: **Preserved Mushrooms** from Chile, China, India, and Indonesia, Invs. Nos. 731-TA-776-779 (Review)</u>

On February 6, 2004, the ITC voted to conduct full reviews to determine whether revocation of the orders concerning this product would be likely to lead to continuation or recurrence of material injury within a reasonably foreseeable time. On February 19, 1999, the Commerce Department issued antidumping duty orders on imports of preserved mushrooms from several countries, including China.

B. <u>Certain Frozen and Canned Warm-water **Shrimp and Prawns** from Brazil, China, Ecuador, India, Thailand, and Vietnam, Inv. Nos. 731-TA-1063-1068 (Preliminary)</u>

The ITC will hold a vote on February 1, 2004 in connection with its antidumping investigation of imports from several countries, including China, of certain frozen or canned warm-water shrimp and prawns that are alleged to be sold in the United States at less than fair value. The products covered are defined as certain warm-water shrimp and prawns, whether frozen or canned, wild-caught (ocean harvested) or farm-raised (produced by aquaculture), head-on or head-off, shell-on or peeled, tail-on or tail-off, deveined or not deveined, cooked or raw, or otherwise processed in frozen or canned form. Excluded from this definition are fresh shrimp and prawns, whether shelled-on or peeled; coldwater shrimp and prawns, in any state of processing; shrimp and prawns in prepared meals; breaded shrimp and prawns; and dried shrimp and prawns. The ITC must reach a preliminary determination in 45 days, or in this case by February 17, 2004. Its views are due at Commerce within five business days thereafter, or by February 24, 2004.

C. **Innersprings** from China, Inv. No. TA-421-5 (Hearing)

Following receipt of a petition filed on January 6, 2004, on behalf of the US-member companies of The American Innerspring Manufacturers (AIM), the ITC has instituted an antidumping investigation and scheduled a hearing in connection with it beginning at 9:30 a.m. on February 19, 2004. The petitioning firms include Atlas Spring, Gardena, CA; Hickory Springs manufacturing Co., Hickory, NC; Leggett & Platt, Carthage, MO; and Joseph Saval Spring & Wire Co., Inc., Taylor, MI. Uncovered innerspring units are composed of a series of individual metal springs wired together and fitted to an outer wire frame and are suitable for use as the innerspring component in the manufacture of innerspring mattresses. The imported products are provided for in statistical reporting number 9404.29.9010 of the Harmonized Tariff Schedule of the United States (HTS).

D. Tetrahydrofurfuryl Alcohol (THFA) from China, Inv. No. 731-TA-1046 (Final)

The ITC will hold a hearing in connection with the final phase of this antidumping investigation on April 13, 2004. The subject merchandise is defined as: "tetrahydrofurfuryl alcohol (C5H10O2) ('THFA'). THFA, a primary alcohol, is a clear, water white to pale yellow liquid. THFA is a member of the heterocyclic compounds known as furans and is miscible with water and soluble in many common organic solvents."

E. Certain **Color Television Receivers** from China and Malaysia, Inv. Nos. 731-TA-1034-1035 (Final)

The ITC will hold a hearing in connection with the final phase of these antidumping investigations on April 15, 2004. The subject merchandise is defined as "complete and incomplete direct-view or projection-type cathode-ray tube color television receivers, with a video display diagonal exceeding 52 centimeters, whether or not combined with video recording or reproducing apparatus, which are capable of receiving a broadcast television signal and producing a video image. Specifically excluded from these investigations are computer monitors or other video display devices that are not capable of receiving a broadcast television signal."

NEWS

- · Floor space for the upcoming 95th China Export Commodities Fair (Canton Fair) is expected to be increased to 240,000 square meters. The fair is scheduled for April 15-30 this year, offering 27,000 booths, 9,000 more than last year.
- According to the US Association of Importers of Textiles and Apparel (USA-ITA), the Bureau of Customs and Border Protection (CBP) plans to launch a document examination blitz at various US ports of entry in March 2004. The blitz will specifically target textile and apparel imports (such as those in categories 350 and 650) which have been misclassified in order to avoid quotas. The CBP will require paper filings during the blitz. It will search for illegal transhipments and counterfeit documents, particularly statements of origin. The last blitz, conducted in June 2003, resulted in 13 per cent of entries being rejected, the majority of which where due to simple clerical entries.

- Five Chinese companies agreed, in 11 separate contracts signed last month, to purchase US\$ 2.32 billion in electronics and communications equipment from US-based firms. China Unicom has awarded a contract to Motorola worth US\$556 million to expand and upgrade its mobile phone network in Beijing. China Mobile, the world's largest mobile operator, awarded Motorola another contract worth US\$510 million to expand its wireless communications network and improve data services in Beijing and 13 Chinese provinces. China Unicom and China Telecom signed a series of contracts worth over US\$350. According to Lucent, the "agreements cover virtually the entire range of Lucent's next-generation network offerings and services that are designed to accelerate the smooth evolution to packet networks as well as enabling the delivery of advanced multimedia communications services." China Telecom and China Unicom both also signed contracts with Cisco Systems, and Lenovo and Founder, two Chinese high-tech firms, struck deals with US chipmaker Intel. The contracts were signed at a ceremony held during the US-China Seminar on Prospects for Cooperation in Telecom and IT. Speaking at the seminar, US Secretary of Commerce Donald Evans hailed the purchase agreements as "a monumental event that represents further strengthening of US-China trade relations."
- · China has started to reduce its average import tariff rate to 10.4% from the current level of 11% percent in accordance with its commitments to the World Trade Organization (WTO).
- According to the China Internet Network Information Center, the number of people who use the internet for more than one hour a week on the Chinese mainland reached 79.5 million by the end of 2003, up 34.5% from a year earlier, and computers linked to the internet had reached 30.89 million, up 48.3%.
- The Shanghai municipal government will focus on attracting foreign investment to five of its main sectors this year: micro-electronics, chemicals, fine steel, shipbuilding and equipment manufacturing. The city aims to attract US\$6.5 billion in foreign investment this year, nearly 20 per cent over last year.
- The State Council, China's Cabinet, has decided to allocate US\$45 billion of the country's foreign exchange reserve for a pilot project that will reform the Bank of China and China Construction Bank of China, two state-owned commercial banks, into joint-stock banks.

NEW REGULATIONS

- Chinese Vice-Minister of Commerce Wei Jian-guo recently announced that the Chinese government will adopt new measures to encourage more foreign companies to set up research centers in Beijing. The measures will be aimed at maintaining preferential policies for such companies, improving the investment environment, and attracting more investment in modern technology. They will also seek to foster the professional development of Chinese officials, entrepreneurs and workers, as well as reduce customs entrance and clearance times for informational, mechanical, electrical and high-tech products, as well as strengthen intellectual property rights for both foreign and Chinese companies.
- Guangdong has established a new food and drug administrative bureau to replace a former
 provincial drug administration as part of a nationwide reform. The bureau, which will operate
 directly under the provincial government, will monitor and supervise food safety, drugs, health
 foods and cosmetics. It will assume some functions of health authorities and also coordinate
 responses to major emergencies. The current system of good manufacturing practices (GMP) will
 remain in place, and new licenses for health foods and cosmetics will be issued in accordance with

new requirements. The results of random inspections are to be publicized, and banned drugs and health foods containing harmful substances will be more tightly controlled.

Its huge MNI database contains profiles of 526,000 Chinese manufacturers and 80,000 trading companies including such useful facts as mailing address, phone, fax, contact name, year established and number of employees. More than 106,000 Chinese company profiles contain Internet websites and more than 91,000 have email addresses.

Its U.S. database is searchable on the Internet at mnileads.com, or on custom CD-ROMs and in 50 individual printed state manufacturers directories. With annual research expenditures in the millions of dollars, MNI information helps companies qualify prospects for both buying and selling. The Evanston IL company can be reached at 800-221-2172.
