RECENT AND UPCOMING U.S. INTERNATIONAL TRADE COMMISSION INVESTIGATIONS HEARINGS

A. Refined Brown Aluminum Oxide from China (Investigation No. 731-TA-1022, Final)

On October 22, 2003, the Commission held a briefing and vote in the final phase of this anti-dumping investigation. The product subject to this investigation is refined brown aluminum oxide, defined as "ground, pulverized or refined artificial corundum, also known as brown aluminum oxide or brown fused alumina, in grit size of 3/8 inch or less. The subject product includes brown artificial corundum in which particles with a diameter greater than 3/8 inch constitute less than 50 percent of the total weight of the batch. The Commission had already determined that there is a reasonable indication that a U.S. industry is materially injured by reason of imports of refined brown aluminum oxide from China that are allegedly sold in the United States at less than fair value. The meeting was open to the public. The Commission is currently scheduled to transmit its determination and Commissioners' opinions to the Secretary of Commerce on or before November 3, 2003.

B. Certain Ductile Iron Waterworks Fittings from China (Investigation No. TA-421-4)

On November 6, 2003, the Commission has scheduled a hearing to determine whether certain ductile iron waterworks fittings from China are being imported into the United States in such increased quantities or under such conditions as to cause or threaten to cause market disruption to the domestic producers of like or directly competitive products. The products subject to this investigation are cast pipe or tube fittings of ductile iron (containing 2.5 percent carbon and over 0.02 percent magnesium or magnesium and cerium, by weight) with mechanical, push-on (rubber compression) or flanged joints attached. Ductile iron waterworks fittings are used to join pipes, valves, and hydrants in

straight lines or to change, divert, divide, or direct the flow of water or sewage in municipal utility and industrial piping systems. Included within this definition are fittings of all nominal diameters and of both full-bodied and compact designs. The hearing is open to the public, and a witness list is expected by November 5, 2003.

NEW REGULATIONS

- China's central government has allowed the establishment of Sino-foreign joint-venture professional recruitment agencies under a newly issued interim agency regulation. In effect, it allows foreign headhunters to recruit expertise ("talents") in China. Foreign companies, however, cannot recruit Chinese expertise without prior approval if the Chinese fall under one of the following categories: engineers or managers engaged in key infrastructure projects or scientific or technological research; active civil servants; experts assigned to western China development projects; or any Chinese serving in a special capacity requiring security clearance.
- On October 1, 2003, the restrictions that designated certain hotels for foreigners staying in Beijing were lifted by the Beijing Public Security Bureau to better serve the increasing number of overseas visitors to the capital. In the past, foreigners from overseas could only stay at star-class or designated hotels while in Beijing.
- Wal-Mart has become the target of the All-China Federation of Trade Unions (ACFTU) for refusing to establish trade unions in its branches in China. According to the ACFTU, participation in trade unions is a basic right of employees in all enterprises in China. Wal-Mart contends that, according to Chinese law, a trade union may be instituted only at the request of its employees, and since there have been no requests to date, there is no need to establish a union. According to the ACFTU, however, employees of foreign-funded companies wish to have their own trade union but have not raised the issue for fear of losing their jobs or other benefits.

China has promulgated a set of administrative rules governing auto financing companies (AFCs) under its WTO obligations. The rules were issued by the China Banking Regulatory Commission (CBRC), with approval from the State Council. Upon its entry into the WTO in December, 2001, China was committed to allowing the establishment of non-bank financial institutions to provide auto financing services. The new rules, containing five chapters with 42 articles, set forth an AFC's functions, conditions for incorporation, change and termination, the business lines permitted to it, and penalties for non-compliance.

RECENT COURT DECISIONS

The Beijing No. 1 Intermediate People's Court ruled against the Beijing New Oriental School in a copyright and trademark infringement lawsuit brought against it by ETS and GMAT. The New Jersey-based Educational Testing Services (ETS) develops and sponsors the widely recognized "Test of English as a Foreign Language" (TOEFL) and "Graduate Record Examination" (GRE), two examinations that students from non English-speaking countries must take before applying to graduate schools in the US. It holds copyrights for the tests in the US and has registered "TOEFL" and "GRE" as trademarks in China. The Virginia-based Graduate Management Admission Council (GMAC) develops and sponsors the "Graduate Management Admission Test" (GMAT), which is similarly registered. The New Oriental School, a well-known private English training center, had been selling pirated copies of the TOEFL, GRE and GMAT tests. The Beijing court ordered the school to cease its illegal activities, turn over all illegal copies of the tests, and to pay 10 million yuan (US\$1.21 million) in compensation. In addition, the school must pay an additional 8.9 million (US\$1.1 million) and 410,000 yuan (US\$49,580) to ETS and GMAC respectively for economic losses, as well as pay legal fees of 1.016 million yuan (US\$122,900).
